- Medical Review Officer (MRO) Services: positive results are reviewed by a specially licensed physician for final diagnosis ensuring that no one will be falsely accused of drug abuse, thus duly protecting both the employee and the employers' interests.
- Samples confirmed positive are stored for 1 year for litigation purposes.
- Split sample testing (2 vials) for every specimen.
